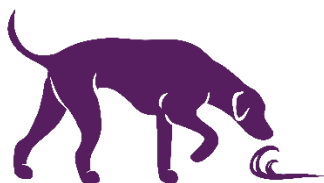

Rosettes are awarded for Passes. Awards are given for 1<sup>st</sup> place in each class.

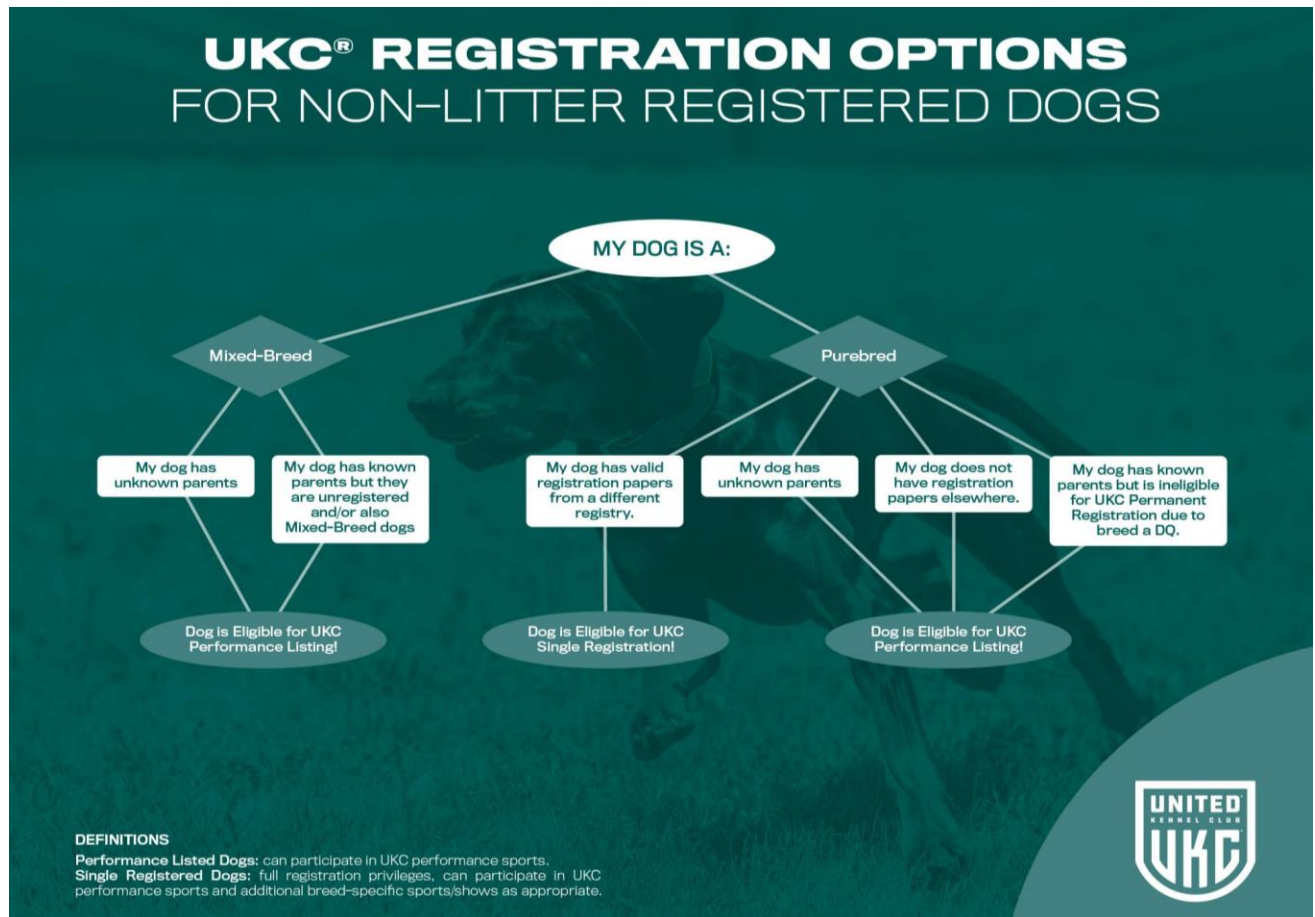
### Venue:

Exhibitors will be crating out of their vehicles. Please pack food and water for you and your dog. More information about where to park and what to bring will be sent out in the welcome letter before the trial.

### Notice to Exhibitors:

- No refunds will be made for cancellations after the closing date, or entries which are absent, disqualified, excused or barred from competition by decision of the Trial Committee.
- Common Scents Dog Sports has the right to refuse entry to any dog or handler. However, no handler shall be refused on the basis of religion, race, color, national origin, age or sex.
- Exhibitors are responsible for complete, accurate and legible information on their entry forms. Incorrect information submitted on the entry form invalidates your pass or placement.
- It is expressly understood that exhibitors alone are responsible for behavior of their dogs, children and/or guests. Any exhibitor whose dogs, children and/or guests repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Trial Committee, be asked to leave the trial site. In such case, no refund on any entry will be made.
- All dogs must be on leash at all times except when competing.
- Exhibitors are responsible for being in the staging area when it is their turn to run.
- Please be courteous and pick up after your dog.
- All entries must be accompanied by entry fees in order to be valid. A declined payment or returned check does not constitute a valid entry. There will be a \$40 fee for any returned check or payment.

## How to register your dog for UKC if your dog does not have UKC papers:

- **Non-UKC Registered Dog Fee** - A \$5 additional fee will be assessed to dogs not temporarily listed, performance listed or permanently registered with UKC. This fee is to be forwarded to UKC with the event recording fees. Participants have 60 days in which to complete the registration application to UKC to retain passes earned. Failure to complete the registration process and/or registrations denied will result in no pass being credited. Applicants should include documentation of any passes earned while applying for registration papers

**Dogs must be at least 6 months old to be entered in Elite Shed Dog Series events.**
