Dogs must be registered with the North American Sport Dog Association. Registration is a one-time fee of \$25. You may register your dog online at <http://nasda.dog/registration/>. (Registration number can be acquired at the trial site).

Awards:

Ribbons are awarded for qualifying score, Best of Breed and High in Class.

Rosettes are awarded for New Titles.

The following 2 awards will earn 1 free run at a future Common Scents Dog Sports trial:

All-Around Award: Cumulative total points *Awards versatility and consistency

High in Trial Overall:

Cumulative high in trial points across classes (highest level entered) *Awards speed and accuracy

Venue:

Exhibitors will be crating in their vehicles. Common Scents Dog Sports reserves the right to remove any individual for any reason from the premises. No refunds will be issued. Please pack food and water for you and your dog.

Notice to Exhibitors:

- Cancellations before the closing date will be refunded minus a 5% fee.
- No refunds will be made for cancellations after the closing date, or entries which are absent, disqualified, excused or barred from competition by decision of the Trial Committee.
- It is expressly understood that exhibitors alone are responsible for behavior of their dogs, children and/or guests. Any exhibitor whose dogs, children and/or guests repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Trial Committee, be asked to leave the trial site. In such case, no refund on any entry will be made.
- All dogs must be on leash at all times except when competing.
- Exhibitors are responsible for being in the staging area when it is their turn to run.
- Please be courteous and pick up after your dog.
- Common Scents Dog Sports reserves the right to refuse any entry without cause or explanation and reserves the right to remove any individual for any reason from the premises
